- c) Experience in social protection policy development and advocacy.
- d) Experience in facilitating policy development working groups and conferences.
- e) Experience in small island states would be a plus.
- f) Fluency in English.
- g) Demonstrated ability to deal sensitively in multi-cultural environments.
- h) Excellent diplomacy and demonstrated political acumen.

The Ministry of Economic Development now invites selected individual consultants to submit their "Expression of Interest" (EOI) for providing the services. Interested <u>individual</u> <u>consultants</u> should provide information demonstrating that they have the required qualifications and relevant experience to perform the services along with the following documents:
