- 6- MRF 1000/- (Maldivian Rufiyaa One Thousand) will be charged as Provisional Registration Fee.
- 7- MRF 100/- (Maldivian Rufiyaa One Hundred) will be charged as Revenue Stamp charges for Provisional Registration.
